- NAMES:** Patriot or Patriot Environmental means Patriot Environmental Laboratory Services, Inc. Applicant or Customer means the entity reflected on this form as APPLICANT – LEGAL NAME.
- APPLYING FOR CREDIT:** Credit Application is to be completed thoroughly. If the Credit Application is not adequately completed, there may be a delay in its processing or it may not be processed.
- INTEREST:** Interest will be charged to Customer at 9% on past due amounts based on the terms of each invoice. Interest will be paid upon demand.
- PAYMENT:** Payment is due within thirty (30) days of invoice date. Payment to Patriot shall not be based on when the Customer receives payment from its Customer.
- PAST DUE INVOICES:** Should an invoice become past due when an entity other than the Customer is responsible for payment of the invoice, the Customer agrees to pay the invoice within twenty (20) days of notification of the past due status.
- COST OF COLLECTION:** In any action to enforce collection of past due invoices or any other legal action arising out of the Credit Application, the Customer shall pay for all of the costs, collection agency fees, expenses, and reasonable attorney's fees incurred by Patriot and/or its agents.
